ID AYU0136) with 100 seats in UG (BAMS) course for the academic session 2023-24 under section 28 of NCISM Act 2020 and relevant regulations thereunder-reg.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act,1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under.

Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, 2020 shall not be applicable.

- 1. In reference to your application vide RDSAGSH/2096/22 dated 29.11.2022 for seeking permission of Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine to start 01 new PG course with 05 seats in the subject namely Prasuti and Stri Roga under section 29 of NCISM Act, 2020 from the academic session 2023-24 and to verify the physical and other infrastructure facilities available in your college for issuance of Letter of Intent, visitation of your college was conducted on 20.04.2023 & 21.04.2023 through Hybrid Mode and as your college was fulfilling the Criteria as per MSR 2016, Letter of Intent was issued to you vide letter of even no. dated 13.05.2023.
- 2. Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college namely Rani Dullaiya Smriti Ayurved PG College & Hospital Barkhedi kalan, Bhadbhada Road, Bhopal-462044, Madhya Pradesh (Inst. ID AYU0136) inspection was conducted on 22.08.2023 and 23.08.2023 on hybrid mode as a part of annual visitation and for issuance of LOP by the visitation team of Medical Asessment and rating Board, NCISM to process the Conditional permission with 100 seats in UG (BAMS) Course under Section 28 of NCISM Act, 2020 for the academic year 2023-2024 and for issuance for LOP to start 01 new PG courses with 05 seats in the subject namely Prasuti and Stri Roga under section 29 of NCISM Act, 2020 from the academic session 2023-24
- 3. Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016" The Indian Medicine Central Council (Post-graduate Ayurveda Education) Regulations, 2016" and provisions under the NCISM Act, 2020 and relevant Regulations there under.
- 4. As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the 57<sup>th</sup> Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on 05.09.2023. On careful examination of the assessment report it is found that your college is fulfilling the notified & approved criteria for issuance of permission in existing UG (BAMS) course and not fulfilling the criteria for issuance of letter of permission to start 01 new PG courses with 05 seats in the subject namely Prasuti and Stri Roga. Hence Board decided to issue the Conditional permission with 100 seats in UG (BAMS) course under Section 28 of NCISM Act, 2020 for the academic year 2023-24 and to provide an opportunity of hearing to the college for issuance of LOP.
- 5. Therefore, Conditional Permission is granted to Rani Dullaiya Smriti Ayurved PG College & Hospital Barkhedi kalan, Bhadbhada Road, Bhopal-462044, Madhya Pradesh (Inst. ID AYU0136) with 100 seats in UG (BAMS) course for the academic session 2023-24 under section 28 of NCISM Act, 2020 subject to the condition that college is fulfilling the following requirements: -
  - I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and

regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

- II. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for academic year 2023-24 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.
- III. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no.BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatary Committee (FRC) of respective State/UT/Deemed to be University.
- 6. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
- 7. Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or subsequent year.
- 8. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- 9. The following requirements should be fulfilled by the college by 31<sup>st</sup> December, 2023 and send a compliance report to get permission for the academic session 2024-25:-
  - all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
  - iii) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto; and
- 10. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2024-25.

RDSAGSH/2096/22 dated 29.11.2022, on the subject cited above and to verify the available facilities of teaching, non-teaching, hospital staff and other facilities available at your college namely Rani Dullaiya Smriti Ayurved P.G College & Hospital Barkhedi kalan, Bhadbhada Road, Bhopal-462044, Madhya Pradesh (Inst. ID AYU0136) to start 01 new PG courses with 05 seats in the subject namely Prasuti Tantra and Stri Roga under section 29 of NCISM Act, 2020 from the academic session 2023-24, visitation has been carried out for issuance of Letter of Intent on 20-04-2023 & 21-04-2023 through hybrid mode by the visitation team of Medical Assessment and Rating Board (NCISM) and as you were fulfilling the basic eligibility criteria, accordingly Letter of Intent (LOI) was issued to your college vide letter of even no. dated 13.05.2023.
- Further, an email dated 03.06.2023 enclosing a letter vide ref. no. RDSAC&H/1257/23 dated 03.06.2023 was received from you informing that you are not willing to continue the PG course in the subject namely (i) Rachna Sharir- 05 seats (ii) Dravyaguna Vigyana 05 seats in the academic session 2023-24 and same was approved in the 42<sup>nd</sup> board meeting of MARBISM held on 07.06.2023.
- 3. Accordingly, inspection of your College was again conducted on 22.08.2023 & 23.08.2023 on Hybrid mode as a part of annual visitation by the visitation team of Medical Assessment and rating Board, NCISM to process for issuance of <u>Conditional permission</u> with intake capacity of 100 seats in UG (BAMS) course and 35 seats in 07 PG courses in the subjects namely (i) Agad Tantra avum vidhi Vaidyaka- 05 seats (ii) Ayurveda Samhita and sidhant-05 seats (iii) Kaumarbhritya-Bala-Roga- 05 seats (iv) Panchakarma-05 seats (v) Rasa Shastra & Bhaishajya Kalpana-05 seats (vi) Shalya Tantra-05 seats (vii) Swasthavritta-05 seats [instead of 45 PG seats in 09 PG courses as per the request of the college vide email 03.06.2023 to not to conduct-PG in the department of Dravyaguna & Rachna Sharir in the academic year 2023-24] under section 28 of NCISM Act,

2020 for the academic session 2023-24 and for *issuance of Letter of permission* to start 01 new PG courses with 05 seats in the subject namely Prasuti tantra and Stri Roga under section 29 of the NCISM Act, 2020 from the academic session 2023-24 and relevant regulations thereunder.

4. Further, in view of above, the visitation report and all other related documents were assessed in terms of enforced regulation namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", "Indian Medicine Central Council (Post-graduate Ayurveda Education) Regulations, 2016" and provisions under the NCISM Act, 2020 and relevant Regulations there under. On examining the case in light of above notified and approved criteria and on perusal of the visitation report, it was observed that the college was not fulfilling the basic eligibility criteria for issuance of permission in existing PG courses due to following shortcomings: -

- 5. In view of above, the assessment report was placed in the 57<sup>th</sup> Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on 05.09.2023. On careful examination of the assessment report, Board discussed the same and decided to issue conditional permission with intake capacity of 100 seats in UG (BAMS) course for the academic year 2023-24 and considering the deficiencies observed therein as mentioned above decided to provide an opportunity of hearing to the college for issuance of permission in existing PG courses and for issuance of LOP to start new PG course.
- 6. As per the decision, conditional permission with intake capacity of 100 seats in UG (BAMS) course for the academic year 2023-24 was issued to you vide letter of even no. dated 06.09.2023 and you were given an opportunity of virtual hearing for issuance of permission in existing PG courses and for issuance of LOP vide the MARBISM letter (Hearing notice) of even no. dated 12.09.2023 to appear on 13.09.2023 before the designated Hearing Committee to present their case and to show cause as to why not the permission to your college with 35 seats in 07 PG courses in the subjects namely (i) Agad Tantra avum vidhi Vaidyaka- 05 seats (ii) Ayurveda Samhita and siddhant-05 seats (iii) Kaumarbhritya-Bala-Roga- 05 seats (iv) Panchakarma-05 seats (v) Rasa Shastra & Bhaishajya Kalpana-05 seats (vi) Shalya Tantra-05 seats (vii) Swasthavritta-05 seats under section 28 of NCISM Act, 2020 for the academic session 2023-24 [instead of 45 PG seats in 09 PG courses as per the request of the college vide email 03.06.2023 to not to conduct PG in the department of Dravyaguna & Rachna Sharir in the academic year 2023-24] and for issuance of Letter of permission to start 01 new PG courses with 05 seats in the subject namely Prasuti tantra and Stri Roga under section 29 of the NCISM Act, 2020 from the academic session 2023-24 be denied. The college was directed to make written submission in respect of the case and produce all relevant valid documents/records/proof to substantiate the claims against all the deficiencies/shortcomings as indicated above. The representatives of the college submitted written submissions vide letter no. RDSAC&H/1931/23 dated 12.09.2023 against the deficiencies conveyed to them.
- 7. Whereas, the college through its representatives, Dr. Prashanth Nath, I/c Principal appeared before the Hearing Committee on 13.09.2023 and made their submission virtually as well as written submission against the shortcomings communicated to the college. The shortcomings communicated to the college, submission made by the representatives of the Ayurveda college and observations made by the Hearing Committee are as under: -

# 1. Teaching staffs: -

1.a).1 The college is having deficiency of only one professor n the department of Kaumarbhritya-Balarog for the UG course which is covered under the provision of Point (iv) of Schedule V of the Indian Medicine Central Council Requirements of Minimum Standard for under graduate Ayurveda Colleges and attached hospital) Regulations, 2016 for grant of conditional permission for UG course.


The College fulfilled all the requirements for teaching faculty for 07 PG courses already existed (i) Agad Tantra avum vidhi Vaidyaka -05 seats (ii) Ayurveda Samhita and Siddhant-05 seats (iii) Kaumarbhritya-Bala-Roga-05 seats (iv) Panchkarma-05 seats v) Rasa Shastra and Bhaishajya Kalpana - 05 seats (vi) Shalya Tantra -05 seats (vii) Swastharvritta 005 seats) and to start 01 new PG course with 05 seats in the subject namely Prasuti and stri roga.

Regarding the deficiency reflected in the Hearing Notice for PG course in Kaumarbhritya-Balarog it is submitted that the college is having 01 Reader namely Dr. Deepak Kumar Jain and 01 Lecturer namely Dr. Manish Ishwarkar. The attested copies of copies of documents regarding their educational qualification, appointment order, ioining letter, experience certificate attendance register up to the month of the visitation (i.e. day August, 2023), Biometric Attendance statement, Form-16, Bank payment details for the Salary, EPF/ESIC details, as desired vide the hearing notice (Annexure-II).

**1.a).1** College submitted that professor in the department of Kaumarbhritya got relived in the month of march 2023 and they could not get a suitable candidate for the post till now.

College is taking necessary steps to recruit professor.

Shortcomings persists.



- 8. The observation of hearing committee based on the submission made by the college representatives during hearing and assessment report of the NCISM have been carefully re-examined in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", "Indian Medicine Central Council (Post-graduate Ayurveda Education) Regulations, 2016" and provisions under the NCISM Act, 2020 and relevant regulations thereunder, and once again as per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the recommendation of Hearing Committee was placed in the 58<sup>th</sup> Board meeting of Medical Assessment and Rating Board for Indian System of Medical Assessment and Rating Board for Indian System of Medical Assessment and Rating Board for Indian System of Medical Assessment and Rating Board for Indian System of Medical Assessment and Rating Board for Indian System of Medical Assessment and Rating Board for Indian System of Medical Assessment and Rating Board for Indian System of Medical Assessment and Rating Board for Indian System of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on 14.09.2023.

In view of the observation of Hearing Committee based on the submission made by the college representatives during hearing and assessment report has been carefully examined in terms of concerned Regulation and provisions under the NCISM Act, 2020 and relevant regulations thereunder, and board decided that the college is <u>fulfilling the basic eligibility criteria</u> for issuance of Conditional Permission with intake capacity of 30 seats in 06 PG courses in the subjects namely (i) Agad Tantra avum vidhi Vaidyaka- 05 seats (ii) Ayurveda Samhita and sidhant-05 seats (iii) Panchakarma-05 seats (iv) Rasa Shastra & Bhaishajya Kalpana-05 seats (v) Shalya Tantra-05 seats (vi) Swasthavritta-05 seats under section 28 of NCISM Act, 2020 for the academic session 2023-24 and for issuance of Letter of permission to start 01 new PG course with 05 seats in the subject namely Prasuti Tantra and Stri Roga under section 29 of the NCISM Act, 2020 from the academic session 2023-24 and not fulfilling the basic eligibility criteria for issuance of Conditional Permission with intake capacity of 05 seats in 01 existing PG course in the subject namely Kaumarbhritya-Bala Roga under section 28 of NCISM Act, 2020 for the academic session 2023-24, due to following reasons-

As per sub regulation (7) of Regulation 6 of PG MSR Ayurveda 2016, The minimum additional teaching staff required for starting post-graduate course shall be one Professor or Reader and one Lecturer of the concerned subject, in addition to the teachers stipulated for under-graduate teaching, and the specialty which does not exist as independent department at under-graduate level shall have minimum one Professor or Reader and one Lecturer for starting post-graduate course.

As per sub regulation (8) of Regulation 6 of PG MSR Ayurveda 2016, the post-graduate department or specialty shall have minimum one Professor in concerned subject or specialty from the academic session 2017-18.

<u>In the Department of Kaumarbhritya & Bal Roga-</u> As, college is having 04 eligible teaching faculties in the Department of Kaumarbhritya (01 Associate Professors & 01 Assistant Professor for UG course and 01 Assistant Professor for PG course) and there is non-availability of 01 professor in the concerned subject which is mandatory as per sub regulation (8) of regulation 6 of (PG Ayurveda Education) Regulation 2016 and is not fulfilling the criteria for issuance of permission in the department of Kaumarbhritya & Bal Roga. Therefore, Board decided to issue <u>conditional permission</u> with intake capacity of 30 seats in 06 PG courses in the subjects namely (i) Agad Tantra avum vidhi Vaidyaka- 05 seats (ii) Ayurveda Samhita and sidhant-05 seats (iii) Panchakarma-05 seats (iv) Rasa Shastra & Bhaishajya Kalpana-05 seats (v) Shalya Tantra-05 seats (vi) Swasthavritta-05 seats and <u>Denial of Permission</u> with 05 seats in 01 existing PG course in the subject namely Kaumarbhritya-Bala-Roga [instead of 45 PG seats in 09 PG courses as per the request of the college vide email 03.06.2023 to not to conduct PG in the department of Dravyaguna & Rachna Sharir in the academic year 2023-24] under section 28 of NCISM Act, 2020 for the academic session 2023-24 and to issue Letter of permission to start 01 new PG course with 05 seats in the subject namely Prasuti Tantra and Stri Roga from the academic session 2023-24 under Section 29 of NCISM ACT 2020.

- 10. Further, in accordance of the regulation 6(2)(i)(i) of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019 vide letter of even no. dated 14.09.2023 a letter was sent to you to furnish fixed security deposit worth Rs. 50 lakhs (Fifty Lakhs) by way of a demand draft or online payment to start 01 new PG course with 05 seats in favor of National Commission fund for Indian system of Medicine for the period of five years. In response of the same you have furnished the fixed security deposit in favor of the National Commission fund for Indian system of Medicine through UTR NO. KARBR52023091500794177 dated 15.09.2023 transferred by Karnataka Bank, MP Nagar branch (for a period of three years) and informed the same vide email dated 15.09.2023.
- 11. Therefore, <u>Conditional Permission</u> is issued to Rani Dullaiya Smriti Ayurved P.G College & Hospital Barkhedikalan, Bhadbhada Road, Bhopal-462044, Madhya Pradesh (Inst. ID AYU0136) with intake capacity of 30 seats in 06 PG courses in the subjects namely (i) Agad Tantra avum vidhi Vaidyaka- 05 seats (ii) Ayurveda Samhita and sidhant-05 seats (iii) Panchakarma-05 seats (iv) Rasa Shastra & Bhaishajya Kalpana-05 seats (v) Shalya Tantra-05 seats (vi) Swasthavritta-05 seats and <u>Denial of Conditional Permission</u> with 05 seats in 01 existing PG course in the subject namely Kaumarbhritya-Bala-Roga [instead of 45 PG seats in 09 PG courses as per the request of the college vide email 03.06.2023 to not to conduct PG in the department of Dravyaguna & Rachna Sharir in the academic year 2023-24] under section 28 of NCISM Act, 2020 for the academic session 2023-24 and to issue Letter of permission to start 01 new PG course with 05 seats in the subject namely Prasuti Tantra and Stri Roga from the academic session 2023-24 under Section 29 of NCISM ACT 2020 and relevant regulations thereunder in continuation with conditional permission issued vide letter of even no. dated 06.09.2023 subject to the following conditions-.
  - (i) The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
  - (ii) It is further informed that 15% of undergraduate seats of the permitted intake capacity of 100 seats and 15% of post graduate seats of the permitted intake capacity of 35 seats in 07 PG courses shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2023-24 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.
  - (iii) It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
- 12. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
- 13. Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.

- 14. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- 15. The following requirements should be fulfilled by the college by 31st December, 2023 and send a compliance report to get permission for the academic session 2024-2025:
  - (i) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - (ii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for post-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - (iii) All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
  - (iv) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto;
- 16. This permission to start 01 new PG course with 05 seats in the subject namely Prasuti Tantra and Stri Roga from the academic session 2023-24 as stated above for the first admitted batch of 2023-24 session, will be valid till such time as the first batch of students admitted against these courses appear for the first final examination of the said courses and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 35 of the NCISM Act 2020.
- 17. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2024-25.

Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, 2020 shall not be applicable.

- Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college namely Rani Dullaiya Smriti Ayurved P.G. College & Hospital, Bhopal, Madhya Pradesh (Inst.
