**Subject:-** Grant of Yearly Permission to Rani Dullaiya Smriti Ayurved P.G. College & Hospital, Bhopal, Barkhedi Kalan, Bhadbhada Road, Bhopal-462044, Madhya Pradesh (Inst. ID-AYU0136) with intake capacity of 100 seats in UG (BAMS) course and Yearly permission with 15 seats in 03 PG Courses in the subject namely (i) Rachna Sharir-05 seats, (ii) Kaumarbhritya-Bala Roga-05 seats (iii) Dravyaguna-05 seats and Extended permission with 30 seats in 06 PG courses in the subject namely (i) Agad Tantra avum Vidhi Vaidyaka-05 seats (ii) Ayurved Samhita, Sanskrit & Siddhanta-05 seats (iii) Panchakarma-05 seats, (iv) Rasa Shastra & Bhaisajya Kalpana-05 seats (v) Shalya Tantra-05 seats (vi) Swasthavritta-05 seats and 2<sup>nd</sup> Renewal of permission in 01 PG course in the subject namely (i) Prasuti & Stri Roga-05 seats under section 29 of NCISM Act, 2020 for the academic session 2025-26-reg.

Sir/Madam,

- 1) To assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities at your college **Rani Dullaiya Smriti Ayurved P.G. College & Hospital, Bhopal, Barkhedi Kalan, Bhadbhada Road, Bhopal-462044, Madhya Pradesh (Inst. ID-AYU0136)** inspection was conducted on **24.03.2025 and 25.03.2025 on Hybrid mode** as a part of annual visitation by the visitation team of Medical Assessment and Rating Board, NCISM to process the **permission under section 29 of NCISM Act, 2020 for the academic session 2025-26.**
- 2) The visitation report and all other related documents were assessed in terms of the enforced regulations namely the Minimum essential standards, assessment and rating for undergraduate Ayurveda colleges and attached teaching hospitals Regulations, 2024", Minimum essential standards, assessment and rating for postgraduate Ayurveda colleges and attached teaching hospitals Regulations, 2024 provisions under the NCISM Act, 2020 and relevant Regulations.
- 3) The assessment report was placed in the **125<sup>th</sup> Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) convened on 09.06.2025 and Board concluded that the college is fulfilling the notified & requisite criteria for issuance of permission as per the concerned Acts and regulations .Therefore board decided to issue permission for the academic session 2025-26 after remittance of the remaining monetary penalty amount imposed in the academic year 2024-2025.**
- 4) Further, a reminder letter for remittance of remaining penalty amount of Rs. 75 lakh was issued to you **vide letter of even no. dated 03.07.2025.** In response of the same an email dated 04.07.2025 an enclosing letter vide ref. no. **RDSAC&H/1851/25 dated 04.07.2025** has been received from you wherein you have **paid the second installment of Rs. 25,00,000/- (Twenty Five Lakhs Only) on 04.07.2025 through RTGS vide UTR No:- KARBH25185531735 and requested to allow some more time to remit the remaining imposed monetary amount of Rs. 50,00,000/- (Rupees Fifty Lakh Only) in installments in the upcoming year.**
- 5) Accordingly, your request was placed in the **132<sup>nd</sup> Board meeting of Assessment and Rating Board for Indian System of Medicine (NCISM) held on 09.07.2025 and Board approved the remittance of 2<sup>nd</sup> installment of the penalty amounting to Rs. 25 lakhs for the Academic Year 2024-25 but on the condition that the college shall remit the balance amount of Rs. 50,00,000/- (Rupees Fifty Lakh only) in two equal installments on or before 31<sup>st</sup> December 2025, without fail and same was informed to you vide letter of even no.dated 21.07.2025.**
- 6) Further, an email dated **25.07.2025**, enclosing the letter **vide ref. no. RDSAC&H/2080/25 dated 25.07.2025** was received from you wherein you have requested for continuation of PG course in the department of Rachna Sharir and Dravyaguna for the academic session 2025-26. Accordingly the assessment report was re-verified and following shortcoming/defects were observed:-
